Active members may drive their J/105 in class regattas and charter a J/105 in class regattas. All of the Fleet 8 Highpoint series races are J/105 class regattas. They may also nominate Associate members, which is done with the Associate Member Application from.

5. If the boat is owned by an LLC or in a corporate name, please supply suitable documentation to assure individual ownership. This could include corporate filings and minutes or an LLC registration.
